TESTO 1

Dangerous substances — any liquid, gas or solid that poses a risk to workers' health or safety — can be found in nearly all workplaces. Across Europe, millions of workers come into contact with chemical and biological agents that can harm them.

In fact, in 2015, 17% of workers in the EU reported being exposed to chemical products or substances for at least a quarter of their working time, a proportion practically unchanged since 2000, and 15 % report breathing in smoke, fumes, powder or dust at work.

Some highly dangerous substances are now banned or under strict control. However, other potentially harmful substances are still widely used, and legislation is in place to ensure that the risks associated with them are properly managed.

TESTO 2

Digitalisation is rapidly changing the world of work and requires new and updated occupational safety and health (OSH) solutions. The research programme of the European Agency for Safety and Health (EU-OSHA) aims to provide policy-makers, researchers and workplaces with reliable information on the potential impacts of digitalisation on OSH so they can take timely and effective action to ensure workers are safe and healthy.

The emergence of technologies such as artificial intelligence (AI), big data, collaborative robotics, the internet of things, algorithms, digital labour platforms and, at the same time, an important increase in the population working remotely brings opportunities for workers and employers but also new challenges and risks for OSH. Addressing the challenges and risks and maximising the opportunities depends on how technologies are applied, managed and regulated in the context of social, political and economic trends.

TESTO 3

Men and women are not the same biologically (sex differences) and the jobs they do, their working conditions and how they are treated by society are not the same (gender differences).

Such differences can affect the hazards men and women face at work and how to assess and control them. This is why EU-OSHA researches and raises awareness of the OSH issues facing women at work.

There are differences that affect the risks that men and women face. Women:

- Work in specific sectors and specific types of work
- Balance dual responsibilities at work and home
- Are underrepresented at supervisor and management level
- Are physically different to men, although there is often more variation between women than between men and women, for example, in physical strength.
- Do jobs that are often wrongly assumed to be safe and easy

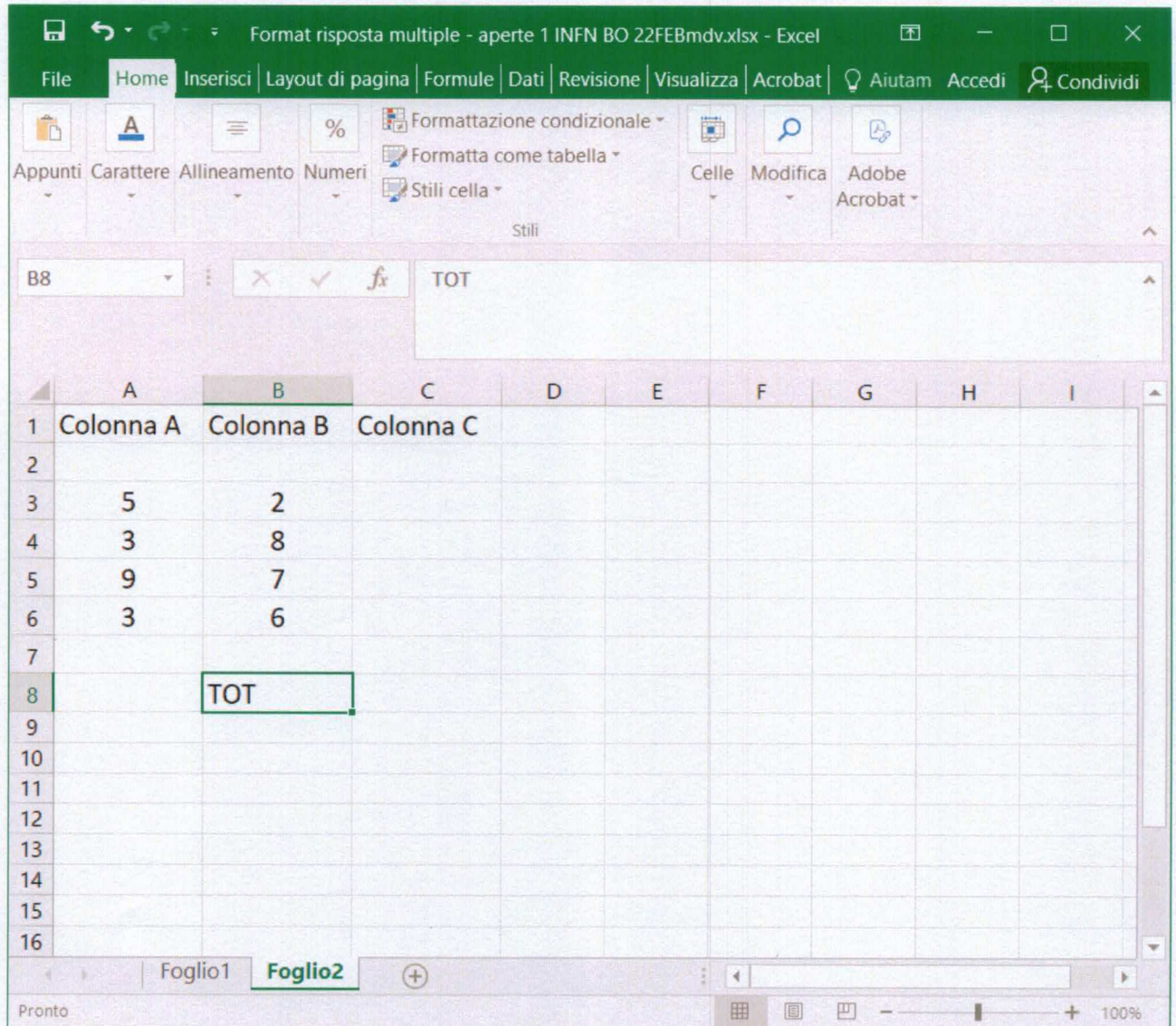
